BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ROCKFORD, ILLINOIS, THAT:



The provisions and sections of this Ordinance shall be deemed severable, and the invalidity of any portion of this Ordinance shall not affect the validity of the remainder.

All orders, resolutions, or ordinances in conflict herewith are hereby repealed insofar as such conflict exists, and this Ordinance shall take effect immediately upon its passage, approval, and publication, as required by law.

A full, true and complete copy of this Ordinance shall be published within ten (10) days after passage in pamphlet form by and under authority of the Corporate Authorities.



ORDINANCE NO. 2015 - _____

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY ROCKFORD, ILLINOIS THAT:

Chapter 105, Article II, Division XI, of the Code of Ordinances of the City of Rockford, Illinois, ~~passed November 30, 1970, approved December 2, 1970 and published December 8, 1970,~~ as amended, be and the same is hereby amended by the following, to wit:

Article II, Division XI, International Swimming Pool Code is replaced as follows:

Article II, Division XI, International Swimming Pool Code adopted by reference:

An ordinance establishing minimum regulations governing the design, construction, alteration, enlargement, repair, demolition, removal, maintenance and use of all swimming pools: providing for the issuance of permits, collection of fees, making of inspections: providing penalties for the violation thereof; known as the Swimming Pool Code.

The ICC International Swimming Pool Code/2015, as published by the International Code Council, Inc. as amended is hereby adopted as the Building Code of the City of Rockford in the State of Illinois; for the control of buildings and structures as herein provided; and each and all of the regulations, provisions, penalties, conditions and terms of said ICC International Swimming Pool Code/2015 are hereby referred to, adopted and made a part hereof as if fully set out in the Ordinance, with the additions, insertions, deletions and amendments contained in this article.

Amendments to the Building Code:

The ICC International Swimming Pool Code/2015 is amended as follows:

(1) Section 101.1 is amended as follows:

101.1 Title. These regulations shall be known as the Swimming Pool Code of Rockford, State of Illinois, hereinafter referred to as “this code”.

(2) Section 103.5 is added as follows:

103.5 Restriction of employees. An official or employee connected with the enforcement of this code, except whose only connection is that of a member of the board of appeals established under the provisions of section 113 of this code, shall not be engaged in, or directly or indirectly connected with, the furnishing of labor, materials or appliances for the construction, alteration or maintenance of a building, or the preparation of construction documents thereof, unless that person is the owner of the building; nor shall such officer or employee engage in any work that conflicts with official duties or with the interests of the department.

(3) Section 104.1.1 is added as follows:

104.1.1 Fire Official approval. The Fire Official for the City of Rockford shall have the authority to issue orders based on requirements of this code for matters pertaining to design, materials or equipment when related to fire protection or life safety.

(4) Section 105.6.1 is deleted and replaced as follows:

105.6.1 Work commencing before permit issuance. When a permit is required by this code, and work is started or proceeded fees shall be in accordance with the Fee Schedule of the City of Rockford Code of Ordinances. No permit can be issued for any person, company or contractor until any outstanding permit fines/fees have been paid in full.

(5) Section 105.6.3 is deleted and replaced as follows.

105.6.3 Refunds. No permit fees shall be refunded.

(6) Section 106.16 is deleted and replaced as follows:

106.16 Re-inspection and Testing. Any item of inspection that fails to meet code requirements on the initial or first re-inspection shall be subject to re-inspection fee as determined accordance

with the Fee Schedule of the City of Rockford Code of Ordinances, and charged to the permit holder for each additional re-inspection performed.

(7) Section 108.1.1 is added as follows:

108.1.1 Automatic appeals. In any case where orders or approvals by the Code Official and Director of the Fire Prevention Bureau are not in full agreement, the matter shall be resolved in the following manner: The case shall be reviewed by the Community Development Director and the Fire Chief. If agreement cannot be reached, the matter shall be referred to the City Administrator for review and decision. The decision of the City Administrator may then be appealed to the Building Board of Appeals pursuant to Section 113.1.

(8) Section 108.2 thru 108.7 is deleted.

(9) Section 107.4 is amended as follows:

107.4 Violation penalties. Any person who violates a provision of this code or fails to comply with any of the requirements thereof or who erects, constructs, alters or repairs a building or structure in violation of the approved construction documents or directive of the building official, or of a permit or certificate issued under the provisions of this code, shall be subject to as penalties prescribed by law and punishable by a fine of not less than \$50.00 and not more than \$750.00 dollars.
