### MESSAGE

On April 10<sup>th</sup>, 2012, Operation Clean Sweep 6 was conducted by the following agencies: Rockford Police Department, Stateline Area Narcotics Team (SLANT), Illinois State Police, Winnebago County Sheriff's Police, Rockford Park District Police, Illinois Department of Corrections Parole Division and the Winnebago County State's Attorney's Office.

The operation focused on narcotics complaints from citizens in the Rockford area. During the operation, law enforcement officers conducted investigations at 20 narcotic complaint locations. Listed are the results of the investigations:

The Illinois Department of Correctional Parole Division conducted 31 parole compliance checks during the operation. Of the 31 parole compliance checks, 16 parolees were located. Of the 16 parolees located 15 were compliant and 1 was arrested for a weapons offense. The parolees checked were on parole for narcotics and weapons offenses.

During the operation the properties located at 218 Oakwood Avenue, 1302 Chestnut Street and 3616 Cardinal Lane were condemned by the City of Rockford Building Department for building code violations.

The charges against the listed defendants are merely accusations. They are presumed innocent until proven guilty in a court of law.
