Incident: **Burglary suspect wanted on warrant**

MESSAGE

On Sunday August 4th, 2013 shortly before 3:30 PM, members of the Rockford Police Department responded to a residence located in the 700 block of John Street in regards to a Residential Burglary. The suspect entered the residence by cutting a first floor screen on an open window. The suspect removed several items from the residence.

Rockford Police Detectives conducted a follow up investigation into the incident. The results of the investigation were reviewed by the Winnebago County State's Attorney's Office. The following charge was authorized:

**Deantonio Davis, 20 years of age, Rockford, Illinois
Residential Burglary**

Rockford Police Detectives obtained an arrest warrant for Davis.

The charge against Davis is merely an accusation. He is presumed innocent until proven guilty in a court of law.
