On Wednesday, October 23, 2013 the Winnebago County Grand Jury indicted Dontrell Dashay Littleton on 14 criminal counts stemming from the fatal traffic crash that occurred on September 29, 2013 at 300 Spring Creek Road, which killed Dorothy Galloway and severely injured her husband Howard Riddle.

 - 2 Counts AGGRAVED DRIVING UNDER THE INFLUENCE OF DRUGS INVOLVING DEATH – Class 2 Felony
(Special Sentencing 3-14 years IDOC: MSR 2 years)
 - 4 Counts AGGRAVATED DRIVING UNDER THE INFLUENCE OF DRUGS INVOLVING DREAT BODILY HARM – Class 4 Felony
