MESSAGE

On October 22, 2013 at approximately 2:40pm Rockford Police Officers responded to 4232 Harrison Avenue for a reported home invasion. Officers met with the 30 year old female resident who was home with her two year old child. Also present in the residence was a male acquaintance of the resident. Shortly after the acquaintance arrived at the residence three male subjects unknown to the resident entered apartment through an unlocked door. The suspects removed a computer, television, video game system, and a Nook. The victim tried to stop one of the suspects and sustained a small laceration to her finger. The three suspects and the male acquaintance of the victim all left the apartment.

A neighbor witnessed a red sport utility vehicle leave the apartment complex during this incident.

At approximately 4:00pm a Crime Stoppers tip came in that the suspect red SUV was parked in the 2700 block of Rudeen Close and was occupied by the suspects and a television. Upon officers arrival three male subjects were located inside the red SUV, as was the property reported stolen from the apartment.
