### MESSAGE

Several weeks ago the Rockford Police Department's Narcotics Unit received information about a subject who was selling crack cocaine and heroin at various locations throughout the city of Rockford. An investigation was initiated and the suspect was identified as Stephone Rogers. The investigation concluded on the afternoon of 2/12/14 when detectives with the Narcotics Unit observed Rogers delivering packets of heroin near 12<sup>th</sup> St. and Broadway. As detectives and officers with the community services unit approached Rogers and his associate, both took off running in opposite directions. After a foot chase, both subjects were taken into custody without further incident. Rogers' associate was identified as Lawrence Jackson. Jackson was found to be in possession of 12 bags of cannabis that were packaged for sale. It should be noted that Jackson was just released from prison on 1/28/14 and is currently on parole for a previous drug offense.

Both Rogers and Jackson were lodged in the Winnebago County Jail on the below listed charges.
