### MESSAGE

Within the past few weeks members of the Rockford Narcotics Unit received information about an individual who was selling crack cocaine at different locations on the west side of Rockford. An investigation was initiated by detectives at this point. The investigation revealed the suspect was Andre Richardson. Richardson is currently on parole from the Illinois Department of Corrections.

The investigation concluded on 3/18/14 after detectives with the Rockford Narcotics Unit, Drug Enforcement Administration, and officers assigned to the Community Services Unit took Richardson into custody without incident in a business parking lot in the 3900 block of W. Riverside.

Richardson was charged with two counts of delivery of 1-15 grams of cocaine and one count of delivery of 1-15 grams of cocaine within 1,000 feet of a church. Richardson was lodged in the Winnebago County Jail. Richardson currently does not have a bond
