MESSAGE

The Rockford Police Department District Two Neighborhood Response Unit began receiving complaints and information during the past week of narcotics being sold from the residence located at 1044 Crosby Street, Rockford, Illinois. An investigation was initiated and the suspect was identified as Andre Tucker. As a result of the investigation a search warrant was obtained for the residence at 1044 Crosby Street, Rockford, Il. On 4/4/14 at approximately 6pm Members of the Neighborhood Response Unit executed a search warrant at the residence. A search of the residence yielded an amount of suspected crack cocaine, United States currency and other items associated with drug trafficking.

Arrested: **Tucker, Andre S.** 21, Rockford

Charges: Possession with Intent to deliver more than 1 gram of cocaine but less than 15 grams. Possession of Drug Paraphernalia
