Incident: Narcotics search warrant - 1514 18th Ave

MESSAGE

The Rockford Police Department's Narcotics Unit received information that illegal drugs were being sold from 1514 18th Ave. Upon receiving this information detectives with the Rockford Narcotics Unit began an investigation. The investigation concluded on 7/12/13 when a search warrant was executed on the lower apartment. During the course of the investigation several adults were secured that were located on scene. During the course of executing the search warrant new information was developed which led detectives to obtain a second search warrant for the upper apartment. During the search warrants detectives recovered over 75 grams of cannabis, eight grams of cocaine, United States currency and two handguns. Three of the individuals located on scene were identified as Bruce L. Castleberry, Darrell D. McLin, and Kelly Parker. All three of these individuals were charged with the below listed criminal charges and lodged in the Winnebago County Jail.

Arrested: Castleberry, Bruce L. 34, Rockford

Charges: Possession with Intent to deliver 1-15 grams of cocaine within 1,000 feet of a park, Unlawful Use of Weapon by felon, Resisting a Peace Officer, Possession with intent to deliver 10-30 grams of cannabis

Bond: No Bond (Felony charge, must be set by Judge)
