Members of the Rockford Police Gang Crime Unit, Narcotics Unit and Community Services Unit have been investigating the sale of illegal narcotics at 413 Napoleon Street. A search warrant was obtained and executed on 09/19/14. Upon arrival Detectives located several subjects inside the residence. Upon searching the residence detectives located heroin that was packaged for individual sale, one semi-automatic handgun, US currency, and other items associated with drug trafficking. Two adult females and one male were arrested and lodged in the Winnebago County Jail.
