Incident: **New Warrants for Lamarcus Bassett**

MESSAGE

The Rockford Police Department investigated two incidents occurring in the past three days. On Tuesday 06-17-14, a victim was robbed at gunpoint at 4104 Auburn Street. The victim reported being robbed by two men who were both armed with handguns.

On Thursday 06-19-14, a victim was shot in a drive by shooting in the 800 block of Royal.

Lamarcus Bassett was identified in both incidents as one of two suspects.

Detectives reviewed both cases with the Winnebago County States Attorneys Office and the following charges / warrants were authorized for Lamarcus Bassett.
