MESSAGE

Early Thursday morning on May 8, 2014 members of the Rockford Police Department, the Illinois Department of Corrections and the Loves Park Police Department worked in a collaborative policing operation. This operation was a parole compliance check in the Rockford and Loves Park area.

Officers checked forty-eight locations for compliance under the provisions of the Illinois Department of Corrections Parole restrictions. As a result of this collaborative effort, a firearm, ammunition, two specialty knives, a pair of handcuffs, a pair of leg irons, a pair of nun-chucks and narcotics were recovered in this compliance process.
