MESSAGE

On August 23 and 24, 2013, members of the Rockford Police Department M3 Street Team conducted a prostitution operation within the City of Rockford. The operation targeted areas of the City from where complaints of prostitution and street crime have been received. During the course of the operation, undercover officers targeted individuals involved in street level sex crimes.

The operation resulted in the arrest of 22 individuals.
Eighteen vehicles were impounded due to these criminal arrests.
