MESSAGE

On 9/12/13 Detectives of the Rockford Police Department's Narcotics Unit, along with the Gang Crimes Unit and Illinois Department of Corrections executed a search warrant at 1657 5th Ave. #1. Detectives encountered eight individuals in the residence, several of whom ran upon seeing the police. All individuals were eventually secured without further incident. During a search of the residence detectives located and recovered several pieces of suspected crack cocaine, cannabis which was packaged for sale, a .44 Magnum revolver, and two 9mm semi-automatic handguns. All of the handguns were loaded.

One of the subjects was identified as Ashlynn M. Baxter and she was later charged with Possession with intent to deliver cannabis. One individual was identified as Tareo Henry and he was wanted for a Illinois Department of Corrections warrant and a Boone County warrant. Another subject was identified as Shawnquez Simmons and he was charged with violating conditions of his parole. Another subject was identified as Johnathan Williams and he was arrested for having a confirmed Lake County warrant. Three individuals were identified as Jaylin D. Davis, Dushown Willis, and Trevante Williams. All three of these individuals are from Minnesota. Williams and Willis were charged with resisting a peace officer. Davis was
