MESSAGE

On Wednesday, August 14th, 2013 shortly before 2:00 AM, members of the Rockford Police Department responded to 221 Miriam Avenue in reference to shots fired. Upon arrival to the residence officers learned the residence had been struck numerous times by gunfire. Witnesses to the incident described the suspect vehicle as a smaller red vehicle which left the scene in a north bound direction.

On Thursday, August 15th, 2013 at approximately 2:00 PM, members of the Rockford Police Department went to the address located at 221 Miriam Avenue to conduct follow up investigation. While meeting with the residents, officers located 2 subjects wanted on warrants:

Jasmine K. Leach, 20 years of age, Rockford, Illinois
Rockford failure to appear warrant

Timothy A. Wainwright Jr., 20 years of age, Rockford, Illinois
Rockford failure to appear warrant

Leach and Wainwright were transported to the Criminal Justice Center where they were lodged.

The City of Rockford Community and Economic Development Department Building Code Section responded to the address. The residence was condemned for health and safety violations.
