### ***North Main & Auburn Street Roundabout Project***

On September 16th at 7:00 am the intersection of N. Main Street and Auburn Street will be completely closed to traffic until 7:00 am on September 25th. The limits of the closure on Auburn Street will be from Church Street to Myott Ave., and on N. Main Street will be from Boilvin Ave/Reynolds St. to Wagner Ave. Traffic will not be able to enter this area during the closure. A detour will be posted.

During the closure, work will occur during the night time and early morning hours. Construction activities during the closure will include pavement removal, paving, curb and gutter installation, utility adjustments, and so forth. These activities are being completed under the full closure due to their proximity to the current traffic lanes as well as staging limits.

Drivers are reminded that no turns are allowed at the North Main and Auburn Street intersection.

Businesses are open during construction and the public parking lots are accessible. The public parking lots are located off of Toner Avenue and Latham Pl. Drivers are encouraged to utilize Boilvin Ave and Myott Ave to access the public parking lot at the southeast corner of the N. Main Street and Auburn Street intersection, and Reynolds Street and Church Street for the parking lot at the southwest corner of the N. Main Street and Auburn Street intersection.

Drivers are encouraged to consider alternate routes during the project construction. Drivers are also reminded to obey work zone speed limits and to stay alert for workers when driving through the construction zone.

**US Bus 20 (FAP Rt. 303) – West State Street Sunset Avenue to West of Bridge Over Kent Creek Roadway Reconstruction**

In order to complete construction, pedestrian traffic has been detoured off of West State Street from Kilburn Avenue to Stewart Avenue and Mulberry Street from Kilburn Avenue to Avon Street. All facilities and businesses along West State Street will remain open during construction. The Illinois Department of Transportation has provided a marked detour for pedestrian traffic.

West State Street Roadway reconstruction project is underway. West State Street is closed from Kilburn Avenue to Stewart Avenue and Mulberry Street is closed from Kilburn Avenue to Avon Street. A detour is in place. It is anticipated that West State Street will be closed until mid-November 2013. Central Avenue is open to north and southbound traffic only.

US Bus 20 (FAP Rt. 303) – West State Street, Sunset Avenue to West of Bridge over Kent Creek, Roadway Reconstruction consists of the complete reconstruction and widening of Business Route 20 and the realignment of Jefferson Street. This includes pavement removal, excavation, PCC pavement, HMA pavement, curb and gutter, median, multi-use path and sidewalk construction, storm sewer installation, retaining wall construction, landscaping, street lighting, traffic signal modernization and interconnection, pavement markings, erosion control, maintenance of traffic and all other necessary to complete the improvements.

IDOT will be coordinating with all applicable governmental agencies throughout the project.

**IL- 2 / South Main Street – Illinois Department of Transportation (IDOT) Roadway Project (Beltline Road to 0.4 miles north of Harrison Avenue)**

IL- 2 / South Main Street – IDOT Roadway Project is underway. The project consists of widening and resurfacing, pavement removal and replacement, adding lanes and a barrier median, curb and gutter, adding a bike path, providing right and left turn lanes, and installing lighting and traffic signals. IDOT will be coordinating with all

applicable governmental agencies throughout the project. The project anticipated completion date is late 2014.

**IL- 2 / South Main Street – Illinois Department of Transportation (IDOT) Roadway Project (South of Pond Street to just North of Cedar Street)**

Traffic control, building demolitions, and pre-stage work is underway. The project consists of pavement removal, excavation, roadway re-alignment, PCC pavement, HMA pavement, curb and gutter, landscaped median, multi-use path and sidewalk construction, storm sewer installation, landscaping, street lighting, traffic signal modernization and interconnection, pavement markings, erosion control, maintenance of traffic and all other necessary items to complete the improvements. The project completion date is late 2014.

IDOT will be coordinating with all applicable governmental agencies throughout the project. The City will relay information as it becomes available.

Drivers are reminded to obey work zone speed limits and to stay alert for workers when driving through the construction zone.

**CITY WIDE STREET REPAIRS GROUP #3**

On June 27, 2013 construction began on the City Wide Street Repairs Group #3 project. Work will consist of full width resurfacing with curb and gutter, sidewalk, ADA ramps, driveway approaches and structure repairs as needed at the following locations:

- 1) Greenwood Avenue from Rockford Avenue to Welty Avenue
- 2) Hill Street from Madison Street to 1<sup>st</sup> Street
- 3) Westchester Drive from Highcrest Road to Buckingham Drive
- 4) Ashland Avenue from Irving Avenue to Furman Street
- 5) Benderwirt Avenue from Winnebago Street to Rockton Avenue
- 6) Custer Avenue from Edgemont Street to Grenshaw Street
- 7) Fairview Avenue from Royal Avenue to Alliance Avenue
- 8) Garfield Avenue from Winnebago Street to Rockton Avenue
- 9) Sunset Avenue from Ashland Avenue to Sherman Avenue

- 12) Marvin Street from Green Street to Preston Street

On July 8, 2013 construction work began on the City Wide Street Repairs Group #4 project. Work will consist the following:

Full width resurfacing and curb and gutter replacement with sidewalk, ADA ramps, driveway approaches, and structure repairs as needed at the following locations:

- 1) Camp Avenue from Logan Street to Hancock Street

Full width resurfacing and new sidewalk installation, curb and gutter, ADA ramps, driveway approaches, and structure repairs as needed at the following locations:

- 1) Alma Drive from Phelps Avenue to Mulford Road

Full curb and gutter replacement with sidewalk, ADA ramps, driveway approaches, and structure repairs as needed at the following locations:

- 1) Island Avenue from South Main Street to West Street

- 3) Lincoln Avenue from South Main Street to Weldon Street

### **MORGAN STREET BRIDGE RECONSTRUCTION**

Work on the project continues. The structural steel portion of the bridge is now complete. The bridge deck pour is completed. Approaches to the bridge are complete. Road work and lighting on the west side of the river is currently being installed. Crews are currently working on parapet walls on the bridge. Some completion work will be going on the East side. Work will continue on the project until completion which is scheduled to be December of 2013.

### **City-Wide Sidewalk & ADA Repairs Package G-2013**

This project consists of select removal and replacement of concrete sidewalk, curb/gutter, driveway approach, also installation of ADA curb ramps, and parkway restoration in several locations within the 1<sup>st</sup>, 2<sup>nd</sup>, 3<sup>rd</sup>, 4<sup>th</sup>, 5<sup>th</sup>, 6<sup>th</sup>, 8<sup>th</sup>, 9<sup>th</sup>, 10<sup>th</sup>, 11<sup>th</sup>, 12<sup>th</sup>, and 14<sup>th</sup> Ward; specifically on 1<sup>st</sup> Street, 2<sup>nd</sup> Avenue, 5<sup>th</sup> Avenue, 19<sup>th</sup> Street, 31<sup>st</sup> Street, Applewood Close, Belmont Boulevard, North Calvin Park Boulevard, Charles Street, Chelsea Avenue, North Church Street, Corbridge Lane, North Court Street, Custer Avenue, Darwood Drive, Fulton Avenue, Jackson Street, Karen Drive, Kishwaukee Street, Lundvall Avenue, Midway Drive, Napoleon Street, Paradise Boulevard, Paris Avenue, Patrick Place, Pierce Avenue, Prial Avenue, Rexford Drive, North Rockford Avenue, Rural Street, Walton Avenue, and White Dove Lane. The sites were selected from the resident call list and are considered a major trip hazards.

### **City-Wide Sidewalk & ADA Repairs Package H-2013**

This project consists of select removal and replacement of concrete sidewalk, curb/gutter, driveway approach, and parkway restoration within the 2<sup>nd</sup> Ward; specifically on Washington Street. The areas were selected based on the resident call list and need.

### **City-Wide Sidewalk & ADA Repairs Package I-2013**

This project consists of select removal and replacement of concrete sidewalk, curb/gutter, driveway approach, and parkway restoration in several locations within the 11<sup>th</sup> Ward; specifically on 4<sup>th</sup> Avenue and 5<sup>th</sup> Street. The areas were selected based on the resident call list and need.

### **City-Wide Drainage Improvements – East H.S. at 10th Avenue**

This project consists of grading and drainage channeling, curb and gutter removal and replacement, manhole and storm sewer installation, pavement patching, and sodding to convey flared end section discharge into the existing storm sewer system.

Contract has been awarded and operations will start on next week.

Drivers are reminded to obey work zone speed limits and to stay alert for workers, when driving through the construction zone.
