Incident: **Narcotics arrest and search warrant at 311 Fairview Ave.**

MESSAGE

For the past few months the Rockford Police Department's Narcotics Unit have been investigating an individual they identified as Lee Willy Lilly after learning that Lilly was involved with selling crack cocaine. As a result of this investigation a warrant was obtained for Lilly for two counts of delivery of a controlled substance (cocaine). On 5/10/13 Detectives with the Narcotics Unit located Lilly at 311 Fairview Ave. where he had been staying. He was taken into custody without incident. During Lilly's arrest additional evidence was located and therefore a search warrant was obtained and executed shortly after. An additional eleven bags of suspected crack cocaine and two bags of suspected cannabis, along with other items associated with drug trafficking was located and recovered. Lilly was lodged in the Winnebago County.

Arrested: Lilly, Lee Willy 44, Rockford

Charges: Possession with Intent to deliver 1-15 grams of cocaine within 1,000 feet of a school, Possession of 2.5-10 grams of cannabis, warrant for two counts of Unlawful delivery of a controlled substance.

Bond (Felony charge, must be set by Judge)

Lilly is presumed innocent until proven guilty in a court of law.
