MESSAGE

On November 30, 2011 Operation Clean Sweep 2 was conducted by the following agencies: Illinois State Police, Stateline Area Narcotics Team/SLANT, Winnebago County Sheriff's Police, Loves Park Police, Rockford Park District Police, Winnebago County State's Attorney's Office, Drug Enforcement Agency (DEA) and the Rockford Police Department.

The operation focused on Rockford and the surrounding communities regarding narcotic complaints from citizens. During the operation officers from eight agencies checked complaint locations, recovered narcotics, arrested offenders including fugitive offenders wanted on warrants.

Officers responded to thirty-nine (39) complaint locations. The following were the results:
