### MESSAGE

Members of the Rockford Police Department's Narcotics Unit and M3 Streets Team have been investigating the report of illegal narcotics being sold from the lower apartment at 1203 20<sup>th</sup> Ave. As a result of this investigation a search warrant was obtained and executed on 2/9/10. Several adults were located inside the residence. During a search of the residence officers located suspected crack cocaine that was packaged individually for sale and a loaded semi automatic handgun. Three adults were arrested and lodged in the Winnebago County Jail.
