

American Rescue Plan Act (ARPA)

January 8th 2024

ARPA Allowable Expenses

- 01** Replace lost **public sector revenue**, using this funding to provide government services up to the amount of revenue lost due to the pandemic;
- 02** Respond to the far-reaching **public health and negative economic impacts of the pandemic**, by supporting the health of communities, and helping households, small businesses, impacted industries, nonprofits, and the public sector recover from economic impacts;
- 03** Provide premium pay for essential workers, **offering additional support** to those who have and will bear the greatest health risks because of their service in critical sectors; and
- 04** Invest in water, sewer, and broadband infrastructure, making necessary investments to improve access to clean drinking water, to support vital wastewater stormwater infrastructure, and expand affordable access to broadband.



2021 Initial ARPA Approach

Take a conservative year by year approach in utilizing funds based on conditions and circumstances for that year.

Allows the City to **ensure sufficient funds are available to maintain services**.

There are still **many unknowns** of the trajectory of the pandemic that we need to be prepared for.

Mitigation measures are again being discussed which could **negatively impact revenues and services**.

Allows for a flat property tax levy so the City **DOES NOT increase property taxes**.


