- 1) Tents, canopies and carnivals erected on City of Rockford property, regardless of time frame, require a permit and City Council approval.
- 2) Tents, canopies erected for more than one day on private property require a permit.
- 3) Tents, canopies where electrical equipment is to be used, regardless of time frame, require a tent permit that includes electrical work. Electrical work shall be performed by a Registered Electrician.
- 4) A tent or canopy permit is required when a tent is more than 120 square feet in size or a canopy is more than 400 square feet in size.
- 5) Tents, canopies or carnivals wishing to operate on private property for more than the permitted number of days (3 days in residential districts, 14 days in other districts) require City Council approval.
- 6) Tent, Canopy, Carnival and Electrical permits shall be posted at the site for the duration of the tent/canopy erection and/or carnival.
- 7) When tents or canopies are more than 120 sf in area, to be used for assembly of more than 10, or heat producing cooking appliances are to be used in proximity of tents/canopies, a request for inspection by the Fire Department Fire Prevention Bureau (779-348-7172) shall be scheduled as soon as possible to be conducted when tent/canopy erection and installation of cooking appliances are nearing completion.
- 8) When electrical equipment is to be used, a request for inspection by the Electrical Division (779-348-7158) shall be scheduled as soon as possible to be conducted when connection of electrical equipment to power source is nearing completion.

V. Applicant's Certificate

The undersigned hereby applies to the City of Rockford, Illinois for a permit to erect (a) tent(s), canopy(ies) and/or carnival as described herein, and if granted, the permit applied for shall comply with all requirements of City Ordinances relating thereto and pay the fees required by such ordinances.
