



To obtain a mechanical license from the City of Rockford,

1. The applicant must qualify and be approved by the Mechanical Board to take the mechanical examination and shall pass the examination as provided by the Mechanical Board. The following qualifications and requirements are from the 2021 International Code Family with amendments including the International Mechanical Code (IMC) as amended and International Fuel Gas Code (IFGC) as amended, and the International Residential Code (IRC) as amended:

All applicants whose applications will be required to be reviewed by the Mechanical Board shall be of legal age, and shall:

1. Have a **MANDATORY** five (5) years of experience in the trade for the class of license he/she is applying for or;
2. Have a degree in related mechanical technologies from an accredited university or college for the class of license he/she is applying for plus one (1) year of practical experience in that class or;
3. Have completed a registered apprenticeship program recognized by the Mechanical Board for the class of license that he/she is applying for.

Upon submittal of the application, the Mechanical Board will review the application at the following Board meeting (see page three for schedule) and determine if the applicant meets the requirements set forth in the Mechanical Code with Amendments to take the license examination. The applicant will be notified within 48 hours of the Board's decision. Examinations are given by the City of Rockford Mechanical Inspector on the second Thursday of every month. The applicant will have 12 months from the date of approval to test or will be required to re-apply. A two-week notice of intent to take the license exam is required*. If testing for more than one license, the applicant can choose to take the exams on separate days, as each one has a 2-hour time limit. The exam is open book based on the 2021 IMC, IFGC, IRC and the local amendments listed on the website www.rockfordil.gov. No electronic devices allowed.

Exam Length: 2 hours

Classes of Mechanical Licenses

Class A Class A license shall be issued to a person desiring to enter into the business of installing, altering, or repairing warm air heating, air conditioning, and ventilating equipment **for residential and commercial properties.**

Class A1 Class "A1" license shall be issued to a person desiring to enter into the business of performing work on detached one (1) and two (2) family dwellings and townhouses not more than three stories above-grade in height with a separate means of egress and their accessory structures constructed under the International Residential Code on warm air heating and cooling (air conditioning) installations, and service replacements. The "A1" license excludes hotels, motels, and any housing units as established by the *International Building Code* (such as group homes, boarding houses, halfway houses and similar uses).

The A1 license ONLY INCLUDES 1 and 2 family residential properties.

Class B Class B license shall be issued to a person desiring to enter into the business of installing, altering, or repairing boilers, hydronics, steam heating, and solar systems.

Class D Class D license shall be issued to a person desiring to enter into the business of installing, altering, or repairing of refrigeration piping of kitchen equipment or equivalent such as: walk in coolers, walk in freezers, dairy cases, ice machines and the refrigerant piping of comfort cooling equipment only.

Class E Class E license shall be issued to a person desiring to enter into the business of installing, altering, or repairing any or all of the consumer gas piping from the point of delivery to the gas cock preceding the appliance **for residential and commercial properties.**

Class E1 Class "E1" license shall be issued to a person desiring to enter into installation, altering, or servicing of any or all of the consumer gas piping from the point of delivery(meter) to the gas shut-off valve immediately preceding the appliance on detached one (1) and two (2) family dwellings and townhouses not more than three stories above-grade in height with a separate means of egress and their accessory structures constructed under the International Residential Code and provided it is under one P.S.I.G. and less than 2 ½" inside diameter pipe. The "E1" license excludes hotels, motels, and any housing units as established by the *International Building Code* (such as group homes, boarding houses, halfway houses and similar uses).

The E1 license ONLY INCLUDES 1 and 2 family residential properties.

Class F Class F license shall be issued to a person desiring to enter into the business of installing prefabricated fireplaces, gas logs, Franklin stoves, inside barbecue burners or pits, and inside charcoal pits.

Geothermal Class A license, Class B license, Illinois Plumbing Contractor registration, and Illinois Plumber's license required.
